# CONSTITUTION <br> Lamb of God Lutheran Church Lake Stevens, Washington 

## Article I. Name

The name of this congregation shall be Lamb of God Lutheran Church (LCMS) of Lake Stevens, Snohomish County, Washington. Lamb of God Lutheran Church, Lake Stevens, Washington is a religious, charitable, and educational organization.

## Article II. Mission

The main purposes or missions of this congregation are to: II. 1 worship, both individually and as a congregation, our Lord and Savior Jesus Christ and, II. 2 share the Good News of salvation with the people of our community and, II. 3 be involved, along with our District and Synod, in our Lord's Great Commission (Matthew 28: 19-20) and, II. 4 extend a helping hand to those in need and, II. 5 especially emphasize Christian education and development of youth and, II. 6 nurture and equip this local body of Christ through Word and Sacrament in order that it can contribute to each of these foregoing purposes.

## Article III. Confessional Standard

This congregation accepts without reservation:
III. 1 The Scriptures of the Old and New Testaments as the written Word of God and the only rule and norm of faith and practice.
III. 2 All the Symbolical Books of the Evangelical Lutheran Church as a true and unadulterated statement and exposition of the Word of God, to wit: the three Ecumenical Creeds (the Apostle's Creed, the Nicene Creed and the Athanasian Creed), the Unaltered Augsburg Confession, the Apology of the Augsburg Confession, the Smalcald Articles, the Treatise on the Power and Primacy of the Pope, the Large
Catechism of Luther, the Small Catechism of Luther and the Formula of Concord.
This Article III shall be irrevocable and unalterable in its essential meaning.

## Article IV. Membership

IV. 1 Reception into membership shall be through
IV.1.1 Sacrament of Baptism, and any of the following as applicable
IV.1.2 Consent of one or both parents in the case of children who have been baptized in another Christian congregation,
IV.1.3 Rite of confirmation,
IV.1.4 Transfer from a sister congregation or
IV.1.5 Profession or reaffirmation of faith.
IV. 2 Individuals who hold membership in organizations whose principles and conduct conflict with the Word of God shall not be eligible for membership.
IV. 3 Reception shall be by the approval of the Pastor and the Elders of the congregation and shall be reported to the congregation.
IV. 4 Members of the congregation (as defined by the preceding 4.1 and 4.3) eighteen years of age or older shall have the right to vote in congregation meetings. Such members are elsewhere referred to as "voters" or the voter's assembly in this Constitution.
IV. 5 Duties. Members of the congregation shall endeavor to conform their entire lives to the rule of God's Word and to that end make diligent use of the means of grace; exercise faithful stewardship of God's many gifts and talents; impart and accept fraternal admonition, in accordance with Matthew 18: 15-20, as the need of such admonition becomes apparent and be readily available for service in the Kingdom of Christ within and beyond the congregation.
IV. 6 Termination.
IV.6.1 Membership shall be terminated by transfer to a sister congregation, release, excommunication or self-exclusion.
IV.6.2 Termination shall be by the approval of the Pastor and the Elders of the congregation and shall be reported to the congregation.

## Article V. Pastors and Called Workers

V. 1 Requirements

This congregation shall establish the pastoral office, which shall be conferred only on such a Pastor or candidate who professes and adheres to the confessional standard set forth in Section III of this Constitution and who is qualified for his work, is a member of the Synod and approved by the Synod. The same shall apply to all other called workers.

## V. 2 Removal

Any Pastor or other called worker may be removed from office by a two-thirds majority vote, by secret ballot, of the voters. The reasons for removal are:
V.2.1 persistent adherence to false doctrine
V.2.2 offensive conduct or scandalous behavior
V.2.3 neglecting the responsibilities of the office or the inability to perform them
V.2.4. domineering in office, this according to the 2003 CTCR document, Theology and Practice of "the Devine Call."
V. 3 Resignation

The voters may request the resignation of a Pastor or other called worker for prolonged incapacity or general incompetence.
V. 4 Vacancies

In the case of pastoral or called worker vacancies, the congregation shall notify the President of the Northwest District so that he may assist in temporarily filling the vacancy an in calling a new Pastor or called worker.

Article VI. Authority of the Congregation
VI. 1 The voter's assembly shall be the governing body of the congregation and shall administer and manage all its affairs. The establishment and conduct of all organizations and societies within the congregation or directly related to it shall be subject to the approval and supervision of the voters. All matters shall be decided by a simple majority vote unless otherwise specified by this constitution.
VI. 2 The right of calling Pastors or other called workers shall be vested in the voters and shall not be delegated otherwise.

Article VII. Officers, Council Leaders and School Association Representatives
This congregation shall have the following Officers, Council Leaders and School Association
Representatives in addition to any others that the voters shall authorize from time to time:
VII. 1 Officers
VII.1.1 a President, who shall conduct the meetings of the voter's assembly and Council VII.1.2 a Vice President, who is to fill the role in the President's absence or inability to act, VII.1.3 a Secretary, who shall keep the minutes of the meetings of the voter's assembly and Council
VII.1.4 a Treasurer, who shall be responsible for the financial records of the congregation and, VII. 1.5 a Financial Secretary who shall oversee the receipt of all monies and deposit the same in an account established in the name of the congregation.
VII. 2 Board of Elders, Council Leaders and School Association Representatives
VII.2.1 A Board of Elders which shall assist the Pastor in the spiritual life of the congregation.
VII.2.2 A Trustee Council Leader who shall be responsible for the physical properties of the congregation.
VII.2.3 School Association Representative(s), whose number is governed by the School Association constitution and bylaws, and who shall represent and act on behalf of the congregation and the board of directors of the School Association.
VII.2.4 A Council Leader for Christian Education who shall be responsible for the nurturing and Christian growth of the members of the congregation and shall establish, maintain and supervise Christian education for everyone in the congregation.
VII.2.5 A Council Leader for Mission and Outreach who shall lead the members of the congregation in reaching out to those in need, both spiritual and physical, in our community and beyond and shall establish and maintain the programs of the congregation for mission, evangelism, social ministry and fellowship.
VII.2.6 A Council Leader for Stewardship who shall be charged with the stimulation of the people to a proper stewardship of time, talents and treasures.
VII.2.7 A Council Leader for Youth and Family who is responsible for nurturing and promoting the spiritual welfare of the youth and young adults.
VII. 3 Authority
VII.3.1 General: Officers, Council Leaders, School Association Representatives and other committees, whether elected or appointed, shall have no authority beyond that which has been conferred upon them by the voters and whatever authority may have been delegated to them may at any time be altered or revoked by the voters.
VII.3.2 Legal Officers: The officers of the congregation empowered to sign legal documents and to serve as the elected officers of the corporation are the President, the Vice President, the Treasurer and the Secretary.
VII. 4 Duties, responsibilities and terms of office shall be further defined, as necessary, in the By-laws.
VII. 5 Removal from office shall be as defined in Article V. 2 or V. 3 of this Constitution.

Article VIII. Synodical Membership
Lamb of God Lutheran Church shall hold membership in The Lutheran Church-Missouri Synod.

Article IX. Division
IX. 1 Division. If at any time a division should take place for any reason, the property of the congregation and all benefits associated therewith shall remain with those members who continue to adhere in confession and practice to the confessional standards set forth in this constitution, as determined by the dispute resolution process described in the Bylaws of the Synod.
IX. 2 Dissolution. In the event the congregation should dissolve, the property (minus any buildings on Zion Lutheran School property) and all rights connected therewith shall be transferred to the Northwest District of the Lutheran Church-Missouri Synod with the prospect that this money will again be used to start and grow ministries for Christ in the Northwest District LCMS. (from NW District). Any building(s) on the Zion Lutheran School property owned by the Lamb of God Lutheran Church will transfer to Zion Lutheran School.

## Article X. Meetings

Regular meetings of the congregation shall be held at least once each calendar year or as prescribed by the By-laws. Special meetings may be called by the President, the Pastor, the Council, the Elders, or by ten voters. Notification shall be given at least two Sundays prior to all meetings. All voters present at a validly called meeting shall constitute a quorum.

## Article XI. Amendments

XI. 1 Amendments to this may be adopted at a validly called meeting of the voters provided that the proposed amendment:
XI. 2 does not conflict with the provisions of Article III and,
XI. 3 has been submitted in writing at a previous meeting of the voters and published prior to the meeting at which it will be acted on and,
XI. 4 receives an affirmative vote of two thirds of the voter's present, has the date of adoption in the amendment and,
XI. 5 is reviewed by the Northwest District of the Lutheran Church Missouri Synod before implementation.
